The Association of Social Work Boards (ASWB) is a nonprofit dedicated to the regulation of social workers. The ASWB owns and maintains the social work licensing and the exams that are used to test social worker's competencies. The cost of the examination is standard across all 50 states.

Examination Fees:

Associates, Bachelors, or Masters exam \$230 Advanced Generalist or Clinical exam \$260

When beginning the process of licensure request a license application from your states regulatory board, submit your application to the board, and follow their steps for registering for the ASWB exam. Other fees may be applicable based on the state you are seeking licensure.
