Rachelle Alterman is the David Azrieli Professor of Town Planning at the Faculty of Architecture and Town Planning at the Technion—Israel Institute of Technology and chairs the Technion’s Graduate Program in Urban and Regional Planning. Dr. Alterman holds a BA Honors and an M.C.P. from Manitoba, a D.Sc. from the Technion and an LLB from Tel Aviv University. Dr. Alterman is well known internationally for her research and numerous publications on comparative planning and land use law, land policy, and planning theory.

Peter Bassin is the Project Manager for the Ljubljana Urban Institute at LUZ, Ljubljana and is the former Division Head at the Institute of Architecture and Urban Design in Ljubljana. In 1996, Professor Franzese was appointed by Governor Whitman to serve as a Commissioner of the New Jersey Election Law Enforcement Commission.

Jules B. Gerard is Professor of Law at Washington University in St. Louis, from which he received his undergraduate and law degrees (A.B., 1957; J.D., 1958). He is a member of Phi Beta Kappa and The Order of the Coif, and was editor-in-chief of the *Washington University Law Quarterly* (1958). Robert L. Glicksman is the Robert W. Wagstaff Professor of Law at the University of Kansas. A 1977 graduate of the Cornell Law School, Professor Glicksman teaches environmental law, administrative law and property law. Professor Payne has written and lectured extensively on affordable housing and regional planning issues, based on his participation in the Mount Laurel litigation in New Jersey, and was President of the Alliance for Affordable Housing, a statewide advocacy coalition. With Professor Mandelker, he is the co-author of *Planning and Control of Land Development: Cases and Materials* (5th Ed., forthcoming 2001).

Peter W. Salsich, Jr. is the McDonnell Professor of Justice in American Society at Saint Louis University School of Law. He holds a joint appointment in the Department of Public Policy Studies and is a fellow of the American College of Real Estate Lawyers. Professor

Salsich is a member of the American Planning Association, Association of American Law Schools, Missouri Bar and the Bar Association of Metropolitan Saint Louis. He received his A.B. from the University of Notre Dame (1959) and his J.D. from Saint Louis University (1965).

Professor Salsich is author of *Missouri Landlord-Tenant Relationship*, and is co-author of *Land Use Regulation, Property Law, State and Local Government in a Federal System*, and *State and Local Taxation and Finance in a Nutshell*. He is the author of chapters in a casebook on housing law and a treatise on state and local government financing. He has published numerous articles and has been an active participant in CLE programs at the local, state and national levels and was a recipient of the Thompson and Mitchell faculty scholarship award and the Student Bar Association Teacher of the Year award. Professor Salsich teaches property, land use, real estate transactions, state and local government, and housing.

Edward J. Sullivan is a partner with the Portland office of Preston Gates & Ellis, LLP specializing in planning, administrative, and state and local government law. He also teaches planning law at Northwestern College of Law and Portland State University. He has participated as an editor and author in all four of the Oregon State Bar Continuing Legal Education publications on Land Use. He was admitted to the Oregon Bar in 1969 and was Washington County (Oregon) Counsel and Legal Counsel to the Governor of Oregon before entering private practice in 1978. Mr. Sullivan has written widely on municipal and planning law topics throughout his more than thirty years of practice. E. Thomas Sullivan—On July 1, 1995 Dean E. Thomas Sullivan joined the University of Minnesota Law School as the eighth Dean and William S. Pattee Professor of Law. Previously, he served for six years as the Dean of the University of Arizona College of Law, and as Associate Dean and Professor of Law at Washington University in St. Louis. He began his teaching career in 1979 at the University of

Missouri, Columbia. On two occasions he was a visiting faculty member at Georgetown University Law Center in Washington, D.C. Dean Sullivan was also a Visiting Scholar twice at Cambridge University in England. Dean Sullivan's teaching areas include antitrust, civil procedure, and regulation of business. He is a nationally recognized authority on antitrust law and complex litigation, having authored or co-authored eight books and over thirty articles and essays on antitrust, including a leading treatise, a casebook and a hornbook on antitrust.

Dan Tarlock is a Professor of Law at the Chicago Kent College of Law. He holds an A.B. and LL.B. from Stanford University and was a Revising Editor of the Stanford Law Review in 1964-65. Professor Tarlock practiced law in San Francisco and Omaha-Denver, and taught at the universities of Chicago, Indiana, Michigan, Texas and Utah. In 1985, he was the Raymond F. Rice Distinguished Visiting Professor, University of Kansas, and in 1996 was the Distinguished Foreign Visitor at the Queensland University of technology in Brisbane, Australia. Professor Tarlock has written and lectured on environmental, land use, natural resources and water resources law in the United States, Australia, Brazil, Canada, China and Europe and consulted widely on these issues. Professor Tarlock is currently a special advisor to the Council on Environmental Cooperation. His publications include *Land-Use Controls* (1981); *Water Resources Management* (Foundation Press 4th ed., 1993 with James Corbridge, Chancellor, University of Colorado and Professor David Getches), *Environmental Protection: Law and Policy* (with Frederick L. Anderson, Robert Glicksman and Professor Daniel R. Mandelker 1999) and *Law of Water Rights and Resources* (1988).

Judith Welch Wegner is co-author with Daniel Mandelker of *State and Local Government in a Federal System*. She has been a professor of law at the University of North Carolina since 1981 and served as dean from 1989-1999. She is currently on leave as a Senior Scholar with the Carnegie Foundation for the Advancement of Teaching, serving as principal investigator of a major study on legal education. She received her B.A. from the University of Wisconsin-Madison in 1972, and her J.D. from UCLA in 1976.
