Perhaps more accurate an estimate was given to the book in question by Professor Manuel Rodriguez Serra: "It is clearly apparent that Dr. von Redlich's book is characterized by painstaking and scholarly research, a judicial attitude and, as it is evident, by soundness of judgment."

The six weeks summer session offers an opportunity: (1) For those who desire to begin the study of law, courses in Criminal Law and Personal Property. (2) For advanced students, courses in Constitutional Law, Insurance and Damages. In special cases beginning students who have had advanced work in Political Science may take Constitutional Law. Advanced students may take any of the courses offered. Each course carries a credit of three semester hours.

Requirements for admission: For students beginning the study of law, the completion of two years of work in an accredited college with an average of C. For advanced students, good standing at a member school of the Association of American Law Schools.

Fees: The tuition fee for each of the above courses is \$25.00 but a student who takes two courses will pay a total tuition fee of \$40.00. In addition, each student pays a registration fee of \$3.00.

Registration Days: June 17 and 18. Class work begins on June 20.
