THE SCHOOL OF LAW

On December 17, 1936, the Law Alumni Lounge Room was dedicated. The Room, furnished with modernistic furniture, is located in the basement floor of January Hall and provides an ideal place for informal discussion and relaxation. The dedication was followed by the annual Christmas Banquet, at which Dean McClain expressed his gratitude to the Alumni for providing the funds which made the Room possible.

On December 10, 1936, the student body adopted a plan for student self-government. The organization adopted the name of "January Inn" and set about at once to promulgate principles and policies which will indicate the scope of its activities. James L. Anding was elected President; Harry Deckert, Vice-President; and Lackland Bloom, Secretary. Two representatives from each of the three classes will complete the Executive Committee.

The entire law faculty attended the Annual Meeting of the Association of American Law Schools in Chicago during the Christmas holiday period. Dean McClain was a member of the Committee on Bar Admissions; Professor Fuller was Chairman of the Round Table on Business Associations; Professor Fuchs delivered a paper on "The Educational Values of a Legal Aid Clinic—Some Doubts and Queries" at the Round Table on Legal Aid Clinics; and Associate Professor Treiman led a discussion at the Round Table on Commercial Law and Bankruptcy on the advisability of retaining acts of bankruptcy in modern legislation.

Professor Charles E. Cullen has been appointed to the Chairmanship of the Committee on the Missouri Annotations to the Final Restatements of the American Law Institute.

Assistant Professor Edward S. Stimson's recent book, *Conflicts of Criminal Laws*¹ has just been released by the publishers. Mr. Stimson who is on leave of absence, is spending the year as a Graduate Student at the Harvard University Law School.
